I. Camp Location:

2. Hours:

Monday Registration: 9:00-9:30 a.m.
CAMP starts: 9:00 a.m.
CAMP ends: 3:30 p.m.
School doors close: 4:30 p.m.

3. Arrivals and Departures:

The pickup and drop off area of the camp is at the main entrance of the Laboratory. Camp monitors will be at the class from 8:30 a.m. to 4:00 p.m. each day.

4. Personal Belongings:

Personal belongings are the camper's responsibility. FOAST will not be responsible for lost or stolen items. Games and other personal belongings from home are not needed and are discouraged. **Games, guns, knives, and other such items are not allowed.**

5. Meals:

The camp fee includes a lunch. There will be no refunds or options on the lunch menu. The camp plans to feed students with Pizza, sandwiches, Hamburg's and Hotdogs. Students may bring a bag lunch if these meals present an issue.

6. Field Trip:

The campers will participate in a field trip to the Department of Fish and Game Shooting Range located on Rabbit Creek Road off the Seward Highway

7. Emergency Care Provisions:

The camp administrator will discuss emergency evacuation procedures on the first day of camp. The camp instructors are trained in first aid.

8. Illness and Accidents:

In the event of a serious accident the person listed as the contact will be called immediately, as well as the paramedics.

9. Discipline:

Attendees are expected to have respectful, mature and well-mannered behavior. Students will be sent home if they cannot comply with camp guidelines.

10. Animals and Pets:

No animals are allowed on the premises.

11. Smoking:

No smoking is allowed.

12. Insurance:

FOAST maintains liability insurance to cover the camp.

LABORATORY & CLASSROOM SAFETY CONTRACT

Participation in lab is a privilege! Students are expected to act responsibly. Consequently, any misbehavior or failure to follow directions and safety rules may lead to the student's removal from the camp. Students will not be able to participate in labs unless this form is signed and in the camp administration's possession.

Lab Rules

1. No unsupervised work is allowed in the lab at anytime.
2. Students may not enter storage areas without express permission of the instructor.
3. Students are not allowed to remove anything from the classroom or lab without permission of the instructor.
4. Do not play around with the equipment!
5. Safety glasses must be worn when indicated by the instructor- no exceptions!
6. Read all lab instructions **before** beginning any experiment and take care to avoid causing an accident by sudden movements or inattention to the experiment.
7. **Dress code will not allow cut off shorts or tank tops. Follow your school dress codes. For lab No open-toed shoes. Care should be taken to keep clothing and hair (tie back) from contacting heat or flames.**
8. Your lab space should be clean upon completion of the experiment.
9. Never taste chemicals. Wash hands thoroughly after every lab.
10. Follow instructor's instructions for disposal of chemicals.
11. Inform the instructor immediately of any accidents or incidents that occur. Any broken glass should be cleaned up and disposed of by the instructor.
